### **APPROVAL OF MINUTES:**

### **OLD BUSINESS:**

### **NEW BUSINESS:**

A motion was made by Commissioner Dallara and seconded by Commissioner Crooks to approve the following employee, Caleb Keller, Corrections Officer, an increase of \$.50 per hour per union contract effective May 16, 2017. The motion was approved as presented.
