BEDFORD COUNTY COMMISSIONERS WEEKLY MEETING

March 22, 2016

The Bedford County Board of Commissioners held their regular meeting in Room 101 of the Bedford County Government Building, 200 S. Juliana Street, Bedford, PA on Tuesday, March 22, 2016. Commissioner Josh Lang called the meeting to order at 10:00 AM and Commissioner Barry L. Dallara gave the prayer of invocation and led the pledge to the flag.

Commissioner Josh Lang, Commissioner Barry L. Dallara and Commissioner S. Paul Crooks were present. Others present were Jill Gordon, Chief Clerk/Director of Elections; Donald Schwartz, Planning Commission Director; David Cubbison, Emergency Services Director; Tammy Lashinsky, Bedford County 9-1-1; Ryan Carbaugh, resident; and members of the public and press.

The Minutes of March 08, 2016 were approved as presented.

A motion was made by Commissioner Crooks and seconded by Commissioner Dallara to approve the corrected expenditure from the meeting of March 08, 2016 General account from \$228,128.79 to \$228,130.79. The motion passed unanimously.

A motion was made by Commissioner Dallara and seconded by Commissioner Crooks to approve the following expenditures:
