

SALARY BOARD MEETING
Meeting Minutes
October 11, 2016

CALL TO ORDER:

The Bedford County Salary Board met immediately following the Commissioners Board Meeting on Tuesday, October 11, 2016. The meeting was called to order by Commissioner Josh Lang at 10:12 a.m.
