

BEDFORD COUNTY BOARD OF COMMISSIONERS

MEETING MINUTES

January 10, 2017

The Bedford County Board of Commissioners held their regular meeting in Room 101 of the Bedford County Government Building, 200 South Juliana Street, Bedford, PA on Tuesday, January 10, 2017. Commissioner Lang called the meeting to order at 10:00 a.m. Commissioner Lang gave the prayer of invocation and led the pledge to the flag.

ROLL CALL OF MEMBERS:

A motion was made by Commissioner Dallara and seconded by Commissioner Crooks to approve the title change of 2nd Deputy to 1st Deputy for Heidi Miller, Register of Wills effective January 10, 2017. This is based upon the recommendation of Faith Zembower, Director or Register of Wills/Records of Deeds. The motion was approved as presented.
