

SALARY BOARD MINUTES

CALL TO ORDER:

The meeting was called immediately following the Commissioners regular meeting at 10:21 a.m.

ROLL CALL OF MEMBERS:

APPROVAL OF MINUTES:

This is based upon the recommendation of Faith Zembower, Director of Register of Wills/Recorder of Deeds.
