

SALARY BOARD MINUTES

November 13, 2018

CALL TO ORDER:

The meeting was called immediately following the Commissioners regular meeting at 10:25 a.m.

ROLL CALL OF MEMBERS:

APPROVAL OF MINUTES:

OLD BUSINESS:

This is based upon the recommendation of Charwin Reichelderfer, Sheriff. The motion was approved as presented.

A motion was made by Melissa Cottle, Treasurer and seconded by Commissioners Dallara to approve the wage of \$11.87 per hour for Travis J. Yarnell, Duncansville, PA a trained part-time Telecommunicator for The Bedford County Department of Emergency Services, effective November 5, 2018. This is based upon the recommendation of David E. Cubbison, Director. The motion was approved as presented.
