REALTY TRANSFER TAX

A State Tax of 1% and Local tax of 1% of the consideration is due when Recording.

All deeds shall set forth the true consideration or be accompanied by a "Statement of Value." The "Statement of Value" shall be fully completed.

All recording fees must be for the exact amount. We are unable to give refunds. We will keep any overages \$5.00 or less. If your overages are over \$5.00 your document will be returned. No more than five documents for one check.

All documents presented with property in more than one municipality or school district must clearly state the proportional share (in whole numbers) as to the division of the local realty transfer taxes.

ALL deeds, mortgages and assignments must have a Certificate of Residence completed and signed in order to record.

When no fee is specified, the fee shall be set by the Recorder of Deeds.

All Fees and said Taxes are payable in advance.

This office accepts, checks, money orders, cash, credit and debit cards. Make all checks or money orders payable to: *Dwight JR Winck Register Recorder.*

The Recorder of Deeds Division is open Monday through Friday from 8:30 AM to 4:30 PM.

Please note: Same-day recording stops at 4:00 PM each day.
